## MEMORANDUM OF INSTRUCTION

September 22, 2022

SUBJECT: 2021 Broward County LTC John Stauffer, JROTC Raider Challenge Championship

1. Purpose: To establish responsibilities and procedures for the conduct of the 2022 Broward County LTC John Stauffer, JROTC Raider Challenge Championship. The date and location are November 5, 2022, at West Broward High School, 500 NW 209<sup>th</sup> Ave, Pembroke Pines, FL 33029.

3. Objectives:
  - a. To provide JROTC Cadets a competitive program in five athletic and curriculum events. The five events for the State qualifier competition are as follows: Raider Fitness Challenge, One-Rope Bridge, Cross-Country Rescue, 5km Team Run and Tire Flip (Annex A-E). The following are supporting objectives: ethical values and good citizenship, leadership potential, effective communication, and logical thinking, improved physical fitness, incentive to live drug-free, positive self-motivation and management, the skills to work as a team member and motivation to graduate from high school and pursue a successful career.
  - b. To provide the maximum number of Raiders the opportunity to compete in athletic and curriculum skills associated with Raider Challenge competition.
  - c. To provide JROTC Cadets the opportunity to practice and familiarize for similar type Raider Challenge Competition held throughout the school year.
  - d. To provide an opportunity for varsity and JV Raider Teams to participate in a championship environment at the County level.
  - e. To judge competing Raider Teams and recognize the top three varsity teams and top two JV teams in each event and overall varsity champions in the Male, Female and Mixed categories.

f. To identify the top two teams in each of the three categories of the varsity division, (male, female, and mixed) and one additional team chosen by the Coordinator, JROTC and Military Programs, Broward County JROTC that will represent Broward County at the 6<sup>th</sup> Brigade Florida Army JROTC Raider Challenge Championship at Camp Flaming Arrow Boy Scout Camp Lake Wales, Florida on December 3, 2022. **The junior varsity division will not advance to the 6<sup>th</sup> Brigade State of Florida championship.**

4. Concept and Policy:

a. **Please email the DAI Office, MAJ Johnson /ISG Valdez with the number of teams in each category you plan to enter NLT October 15, 2022.**

b. **There are three categories of competing Raider Teams in the varsity and junior varsity division.** They are Male Teams: 10 competing males plus up to 2 additional male team members for free substitution at the discretion of the team captain; NOTE: Females are permitted on Male Teams; however, they must compete IAW Male Team standards. Female Teams: 10 competing females plus up to 2 additional female team members for free substitution at the discretion of the team captain; Mixed Teams: 10 competing members of which at least 4 must be females plus up to 2 additional team members used for free substitution at the discretion of the team captain. Mixed teams may have more than the minimum females and no less than 2 males. **Only varsity teams will advance to 6<sup>th</sup> Brigade State of Florida Raiders championship.** All varsity raider will wear team identifying wrist bands.

c. **In the junior varsity division, each participating school is authorized to field at least one team in each category regardless of whether the school has an entry in the same varsity category. Once rosters are declared, as either varsity or JV, on the date of the meet, cadets will be locked in that division and no changes will be allowed. For safety reasons and to allow for maximum participation, JV teams will be allowed a maximum of 20 members per team. JV participants must meet the following criteria:**

- 1) 9<sup>th</sup>-11<sup>th</sup> Grade
- 2) Age 17 or younger.

d. All competing teams must attend the awards ceremony.

e. The SAI/AI's of the competing teams will plan for all matters associated with travel, feeding, security of personal belongings and accountability of personnel and equipment while competing at the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet.

f. Uniforms.

1) JROTC instructors regardless the reason for attendance will wear the OCP uniform with OCP cap.

2) Cadets will compete in a modified OCP/ACU uniform. The modified OCP/ACU Uniform will consist of the OCP/ACU jacket, unique competition shirt or the Army issued tan or coyote t-shirt, OCP/ACU trousers, rigger belt, socks, running shoes. A water carrying devise (pistol belt, full canteen with cover, water bottle, Camel back) and OCP/ACU Cap. At a minimum, cadets may wear the JROTC tag on the front of the jacket. Cadet's name on the OCP/ACU Cap is optional. Programs with approved Distinctive Unit Insignia are allowed to wear them on the OCP/ACU jacket. Cadet name on OCP/ACU jacket is a uniform violation. Competing in the OCP/ACU jacket is solely up to

each competing team. In some cases, the OCP or ACU jacket may serve as a measure of safety for a particular event.

g. Judges will primarily come from JROTC Cadre, Active, Reserve, National Guard service members assisted by current and former Broward County JROTC cadets. The Meet Director will send a separate tasking to schools for judges.

h. Entry Fees. Entry fee of **\$50.00** for one team, **\$75.00** for two teams and **\$100.00** for three teams, **\$125.00** for four teams. Entry fees are required for awards and expenses. Please make checks payable to: **Broward County JROTC Support Association**. Payment is permitted on the event date November 5, 2022, during registration.

i. Parking. Two campus parking lots are designated for participant, judges, coaches, and spectators (teacher parking lot on the east of the school building – enter from Pines Blvd. on NW 209<sup>th</sup> Ave.; student parking lot on the south side of the school – enter from Pines Blvd. on NW 210<sup>th</sup> Ave). Booster club trailers will enter from Johnson St. at 209<sup>th</sup> Ave and park along 209<sup>th</sup> Ave. facing south. Busses will enter from Pines Blvd. at 209<sup>th</sup> Ave. and park along 209<sup>th</sup> Ave. facing north. Bobcat Battalion Booster Club parents and cadets will assist with Booster trailer and bus parking to ensure they do not block the Team Run route.

j. Concession Stand: To be announced by Host School at a later date.

## 5. Responsibilities:

a. Coordinator, JROTC and Military Programs, Broward County JROTC:

- 1) Overall responsibility for the conduct of the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet.
- 2) Provide payment for trophies and awards for the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet.
- 3) Provide the Meet Director for the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet (LTC (Ret.) Kenneth Green).
- 4) Coordinate for JROTC cadre and other judges as required.
- 5) Final approving authority for any grievances or judging decisions at the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet.

b. SAI's/AI's:

- 1) Prepare your respective teams for competition IAW the provisions of this MOI and event annexes published separately.
- 2) Each Raider Team will provide the Director, for the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet with a list of all cadets participating, a letter certifying that you or your school has provided additional insurance as required by this MOI. Provide a list of all cadets participating on a Statement of Eligibility that lists all the members of the Raider Team and certifies that

each Raider is enrolled in JROTC for the current school year, has a valid physical, and meets the Florida High School Athletic Association rules for eligibility for participation in extracurricular high school sports. This Statement of Eligibility will be signed by a school official (principal, assistant principal, or counselor) as well as the SAI, both signatures are required. Teams will not compete without this form (all team members will have a minimum of a 2.0 unweighted GPA).

3) Ensure your team(s) follows the meet schedule and rotation plan.

4) Supervise your Cadets at all times and throughout the entire campus. Destruction of campus facilities and other schools' property will NOT be tolerated.

5) Ensure all cadre, parents, boosters, etc. REFRAIN FROM COACHING ONCE THE COMPETITION BEGINS – encouraging your team is welcomed but NO COACHING PLEASE! Allow the designated Raider Team Commanders to lead their teams and make leadership decisions. SAI's/AI's must ensure all guests supporting their teams DO NOT bring pets of any type, to include dogs, cats, birds, snakes, goats, etc.

6) The host school will provide runners for the use of the Meet Director. No runners or other assistance of cadets from other schools are required.

7) Coordinate with the Coordinator, JROTC and Military Programs, Broward County JROTC, LTC (Ret.) Kenneth Green on all grievances and judging decisions.

6. Scoring Procedures: Verification of all score sheets for administrative accuracy will take place while the team is in the ready area. The competing team's score sheets will be completed prior to the beginning of competition. Immediately after the performance is completed, the event Head Judge will give a quick out brief to the Raider Team's Commander and coach, to include any penalties assessed. The Head Judge will give the score sheet to the scoring committee responsible for tabulating the scores. Upon completion of the tabulation process, all score sheets are placed in each school's/team's folder and are available for pick-up immediately following the awards ceremony. In the event of a tie for overall team trophy placement determination the 5K Team Run is the tie breaker followed by the Rope Bridge.

7. Protests and Appeals: Should any protest, dispute or appeal of a judge's scoring or any other similar circumstance arise, it is the responsibility of the Coordinator, JROTC and Military Programs, Broward County JROTC (LTC (Ret.) Kenneth Green) to decide on the question/issue. Submit all protests to the Meet Director within 30 minutes of the conclusion of the protested event and only by a Cadre member from that school/team.

8. Penalties:

a. Participating teams will meet all scheduled events as outlined in the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet Itinerary of Events. All teams will have a rotation schedule for all five events and the Team Captain is responsible to have it with him/her for the duration of the competition. Teams will follow the rotation schedule in the order of events as published. Team Captains will check in and out with the administration station at each event and will be provided an arrival and departure time for that event. Teams will have 10 minutes to report to the administration station for their next event. If a team fails to report to their next event in 10 minutes, that team will receive a **30 second penalty** for reporting late to that event. After 10 minutes, the team is **disqualified** with no time earned for

that event. This system eliminates the need to send a team representative to their next scheduled event in case of a backlog.

b. Teams that fail to check-in at the event administration station with their entire team will be **disqualified** from participating in that event.

c. A **50 second penalty per occurrence** is levied on all teams that report without proper uniform/equipment. Disqualification may take place depending on the event and significance of the violation as it relates to safety and the teams' ability to accomplish the event. Event OIC must make an annotation on the offending team's scorecard what the violation was and what decision was rendered.

d. In any case of unsportsmanlike conduct involving a team member or the entire team, the Meet Director will determine the severity of the infraction and may assess any penalty up to and including disqualification from an event to the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet.

e. Substitutions of the two authorized additional cadet team members is allowed during the competition before any event starts. All team members who are on the official team roster at the start of the competition can compete in any event at the discretion of the team captain. Regardless of the substitutions of additional cadet team members by the captain, teams must meet the minimum gender requirements specified in paragraph 4.b. of this MOI. Bottom Line: Your team captain may choose between any team members on the registered roster to construct the team best suited to maximize team performance in that event while meeting gender requirements.

f. Cadets will follow CCR 145-2, dated 2 August 2022, paragraph 8-6, Personal Appearance, regarding hair color, length, styles, authorized accessories and jewelry while wearing the modified OCP/ACU in the field environment. If a cadet is found in violation, a **10 second penalty** is automatically added to their overall score or each event per occurrence. If four or five cadets on the same team have uniform violations, a **five-minute penalty** will be added to each event time. If six or more cadets have uniform violations, the team is **disqualified** and will receive no time.

g. Deviations from this MOI must receive approval by the meet director or his/her representative for this Raider Challenge Competition.

## 9. Awards:

a. Trophies are awarded to the Top 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> places in each varsity and 1<sup>st</sup> and 2<sup>nd</sup> place in each junior varsity event. Additionally, trophies will be awarded to the Top 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> places overall in three categories of varsity teams – Male, Female, and Mixed. The junior varsity division will not be awarded overall category trophies.

c. All twelve competitors for each team, including junior varsity, will receive participation ribbons.

10. Inclement Weather Procedures: In the event of inclement weather such as however, not limited to, severe storms, lightning etc... The Raider competition will stop immediately. Judges, coaches, and all Raider teams will move to the nearest building or safe area and wait for instructions from the Meet Director. The Meet Director will make a weather decision based on weather reports. If the competition is halted, the following rules will apply:

- a. If due to inclement weather any event in which more than half of the competing teams have completed, the results in that event will stand and accolades awarded to team placement up to that point.
- b. Events that are less than half completed because of inclement weather, no results and scoring will take place and therefore no further awards presented.
- c. Due to the nature of the event, all funds are used to purchase the necessary items to support the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet. The DAI Office is not able to reimburse schools if the inclement weather procedures go into effect and the competition is not completed.
- d. All coaches/judges will meet in the cafeteria at 0630hrs on November 5, 2022, to reiterate the Task, Conditions & Standards for all events, final uniform decision, to discuss judging specifics and weather information. Event briefing for coaches and team captains will take place in the cafeteria at 0700hrs.

11. Safety:

- a. Responsibility: Cadre at every level are responsible for conducting a continuous, rigorous safety program. Cadre must ensure that adequate provisions for safe physical standards are incorporated into all aspects of training (see CCR 385-10, Cadet Command Safety Program).
- b. Safety Requirements:
  - 1) The Meet Director will have a Composite Risk Management Worksheet completed for all the events prior to the start of competition. Weather will determine the daily risk assessment and changes to events for safety reasons.
  - 2) All applicable training and safety publications are available and adherence to them is a must during the conduct of the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet.
- c. Qualified medical support from the Pembroke Pines Fire Rescue is on call during the competition. SAI/AI's will determine if an emergency exists and will not hesitate to call 911.
- d. Accident/injury reporting requirements are contained in USACC Regulation 385-10.


ANNEX A: (Raider Fitness Challenge) to Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet (MOI), Raider Fitness Challenge

Raider Fitness Challenge

- 1. Task:** Complete the Raider Fitness Challenge course which is designed to examine strength, stamina, strategy, and endurance of the team of cadets over a course approximately ½ mile in length using various obstacles.
- 2. Conditions:** During daylight hours and under existing weather conditions, each member of the 10 member Raider Team will complete the Raider Fitness Challenge in the Raider Team uniform: Running shoes, OCP/ACU trousers, and school t-shirt with sleeves or OCP/ACU t-shirts and some type of water carrying devise. Cadets may wear OCP/ACU tops depending on weather conditions.
- 3. Standards:** The Team is scored on the amount of time that it takes all 10 members to complete the course.
- 4. Concept:**
  - a. A course is set up IAW the diagram in this annex. Time is recorded as the team completes the course. The grader will command “Get set...Go” which will start the clock. The course will consist of the following items in order:
    - 1) Approximately 10 yd. low crawl with 5 lanes established
    - 2) Approximately 40 yd. water can, ammo can, kettle bell, or weighted sandbag carry (each item will vary in weight from 10-30 lbs.)
    - 3) An obstacle to either go over or under
    - 4) A speed agility maze
    - 5) A weighted object to carry around approximately 50’ in length
    - 6) A turn around point (either a cone or pole) and repeat of the course in reverse
  - b. There is only one team on the course at a time. Teams should complete the course within 5-6 minutes. Any team still on the course at the 10-minute mark will be stopped by the grader and will not receive a time for that event. There will be enough items for each team member to carry two items on phase 2 of the course. The weighted object used will not weigh more than 250 pounds. The entire team will carry the object and transport it approximately 50 feet in the designated direction. The team will go around the turnaround point and complete the course in reverse so that all items are returned or placed in the original order where the team picked them up from. Once a cadet crosses the finish line he or she cannot go back to assist. Once the last cadet crosses the finish line, time will stop.
  - c. Judges will record each Team’s total time on the score sheet. Once the Raider Team completes the event score sheets are sent to the Raider Meet Headquarters for verification and posting.
  - d. Judges will instruct the team to make sure all equipment is returned to the original location before continuing to the next phase. If not corrected and they continue, a 2-minute penalty will be assessed. Judges will reset equipment before the next team starts.

ANNEX B: (One-Rope Bridge) to Broward County LTC John Stauffer, JROTC Raider Challenge  
Championship Meet (MOI), One-Rope Bridge

1. Task: Construct a one-rope bridge spanning approximately, Male, 60-feet, Female/JV 50-feet, Mixed, 55-feet.
2. Conditions:
  - a. Under existing weather conditions and in a field environment each Raider team will cross a 40 to 100-foot obstacle by constructing a rope bridge.
  - b. Teams will make only one timed crossing and will compete against the clock. Time will not stop during the conduct of the event unless teams go over the 10-minute time limit. Judges will assess penalties for rule infractions and safety lapses. Total event time is calculated from the crossing time plus any accessed penalty time.
  - c. 10 cadets will compete as a team in this event. Teams with less than 9 cadets will not compete. All Raiders must cross the obstacle on the rope except for the first and last Raider.
  - d. A complete OCP/ACU uniform will be worn by all team members. Caps are not grounded with other equipment but may be carried in the cargo pocket prior to commencing construction of their bridge. Uniforms may be adjusted by the Meet Director at the beginning of the meet depending on heat category. Some type of water carrying devise (pistol belt with full canteen with cover, water bottle, Camel Back) and extra equipment may be grounded.
  - e. The bridge site will include a suitable anchor point on the near and far-side of the obstacle, mounting and dismounting points, and barriers (log, plank, or tape) to mark the obstacle boundary.
  - f. Each Raider team is responsible for providing their own equipment; 1-bridge rope minimum requirement 120 feet long by 7/16-inch diameter (static rope,), 8-10 Swiss seat ropes 14 feet or longer by 7/16-inch diameter, and proper number of snap links to construct rope bridge and Swiss seats. A duffle bag will be used to back feed the rope.
3. Standards: **IAW TC 3-97.61, Military Mountaineering, dated July 2012**
  - a. The Swiss seat must be secured with a square knot and with an overhand knot at each side of the square knot to prevent the knot from becoming untied with at least a four (4) inch pig tail on each knot. First and last Raider may wear sling ropes tied around their waist using a **Swami Belt (TC 3-97.61, pg. 6-24)**. The Swami Belt is tied IAW TC 3-97.61, Military Mountaineering page 6-24 using at least two wraps around the waist and tied off with a square knot with overhand safeties with a minimum 4-inch pig tail on each side. An end of the line bowline with overhand knot or figure 8 hooked into the far side Raider's snap link is used to secure the far side Raider while crossing the stream.

The Swiss seat (rappel seat) is tied IAW TC 3-97.61, Military Mountaineering page 4-29.

**Note: On Step 5, the two ends may travel from bottom to top or top to bottom as long as a half hitch is created on both hips creating a bight.**

ANNEX B: (ONE-ROPE BRIDGE) to the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet (MOI), One-Rope Bridge

b. The only knots allowed for the far side anchor point are one round turn around the anchor point secured by two half hitches, or a tensionless anchor knot (**pg. 5-6**) with a minimum of 4 round turns around the anchor point secured by a snap link which is then secured to the rope bridge rope by an end of the line bowline with overhand knot or figure 8 knot. The only knots allowed for the near side anchor point/tightening system are the wireman's knot and/or the figure 8 slip knot (**Transport Tightening System pg. 7-15, Fig 7-10**) as the tightening system knot; round turn around the near side anchor point secured by two half hitches on a bight. The half hitches on a bight are not required to go over all ropes if it provides a safe knot extending toward the tightening system knot.

c. The two anchor knots, the wireman's knot, or figure 8 slip knot (either may be used to construct the one rope bridge) and two half hitches on a bite will be visually inspected for safety prior to Raiders mounting the bridge rope. If improperly tied, the team is STOPPED and allowed to fix knots, but time continues to run.

d. Teams may tie their Swiss Seats before checking into the OIC. The OIC must watch the team back feed the rope in the duffle bag or similar container. The team will be given five minutes to tie their Swiss Seats and to prepare their rope by back feeding the rope in the duffle bag or similar container. When the team captain feels his team is ready to be inspected, he/she calls time, and the time stops. If a seat is unsafe the team does not get the remaining minutes to tie the seat without penalty. The Swiss seat must pass the CHECKPOINTS on page 4-29 of the TC 3-97.61 to be considered safe and team penalty assessed for unsafe seat.

e. When crossing, **only three Raiders** can clip onto the rope bridge with the Swiss seat at any one time. While crossing, each **Raider is not required to have one leg/foot** in contact with and over the bridge rope. The bridge will not be disassembled until the last Raider has crossed and safely unclipped on the far-side.

4. Concept: Upon arrival at the bridge site, the team will enter the holding area with their bridging equipment and wait for further instructions from a guide or judge. Teams will receive a safety briefing and given the Task, Conditions and Standards for the event. When a lane is clear, the team will then move to the preparation area, receive a site orientation, and begin the 5-minute cross preparations, for tying Swiss seats and to prepare their rope. "Time Start" begins the exercise /event. "Time Stop" ends the crossing/event, the team then gathers their equipment, is given a short debrief, and proceeds to the next event.

5. Bridging Preparation, Construction Cross, and Disassembly:

a. Preparation:

1) The first and last Raiders can tie either a Swami belt (**pg. 6-24**) (around-the-waist harness) or a Swiss Seat. The recommended method for the Swami Belt is with rope that is double wrapped around the waist and tied off with a square knot with overhand safeties with a minimum 4-inch pig tail on each side. The snap-link is then clipped around all coils of the harness. The remaining Raiders will tie Swiss seats with snap-links to aid in transporting themselves across the rope bridge. The snap-link is centered on the body and closed over all the rope parts with the gate facing up and away from the body. A snug seat is a must.

ANNEX B: (ONE-ROPE BRIDGE) to the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet (MOI), One-Rope Bridge

2) The minimum requirement 120 foot or longer bridge rope is uncoiled and back feeding (**TC 3-97.61 par. 4-25**) the rope into a Duffle bag, bucket, tub, or similar container with one end sticking out or over the side of the opening but not touching the ground.

b. Construction: The following steps can be conducted simultaneously.

1) Step One: The far-side Raider ties an end of the line bowline with overhand knot or figure 8 and snaps in before crossing into the stream (dead zone) and is belayed across the stream, (no figure 8 across the body). Belaying involves a stationary Raider or Raiders having control of the bridge rope as the Raider crosses the obstacle (**pg. 9-5**). Too much “slack” is to be avoided to sense the movement of the crossing Raider and to ensure an immediate safety response.

2) Step Two: When the far-side Raider reaches the far-side, he/she unclips once out of the dead zone and moves to the anchor point and prepares to tie one of the approved anchor knots. The far-side raider must be belayed while crossing and can be stopped being belayed once he/she unclips from the rope.

**NOTE:** Step three can be executed at the same time as step one and two if the far side Raider is on belay.

3) Step Three: On the near-side, approximately 3 meters from the near-side anchor, a wireman’s knot or figure 8 slip knot is tied into the bridge rope, a wooden, metal, plastic stick/implement or a snap link can be used to aid in the disassembly of the knots or also used for securing the near side. (**Transport tightening system pg. 7-15 Fig. 7-10**). Inserting the stick/implement is accomplished by placing it into the upper wing above the butterfly of the knot (upper bight of the wireman’s knot). Teams may not use the stick/implement as a speed tightening device. The fixed loop formed in the knot must naturally lie toward the near-side anchor.

The fixed loop is placed into the one (locking carabineer/snap link minimum standard is 9 kilo newton (KN) military steel or aluminum) or two (2) snap-links with gates opposed (**pg. 5-5**). The remainder of the bridge rope is routed around the anchor point and through the snap-links. Coaches or cadets cannot alter or modify carabineers in any way. If so, the team is disqualified from the event.

4) Step Four: When the bridge rope has passed through and is secured by the carabineer or two (2) snap-links in the wireman's knot or figure 8 slip knot, the far-side Raider now detaches the "temporary" snap-link and pulls the wireman's knot or figure 8 knot out from the near-side anchor point approximately 4 to 6 feet and then secures the far side bridge rope to the anchor with one round turn and two (2) half hitches on a bight with a four inch (4") pig tail, or tensionless anchor knot ensuring the knot is at least waist high.

5) Step Five: The Raiders on the near side tighten the bridge rope with their pull team. The pull team on the near side pulls the slack out of the bridge rope. The carabineer or two (2) snap-links should be close enough to the near side anchor to allow personnel to easily load the bridge. The bridge rope should be tight enough to prevent crossing Raiders from making contact with the stream or ground. The transport tightening system is then secured to the anchor using a round turn and two (2) half hitches on a bight. The half hitches do not have to pass around/over all the ropes between the anchor point and the wireman's knot or figure 8 slip knot.

c. Crossing: The Raider will use the Rappel Seat Method (**pg. 7-20**), with the carabineer facing up and away from his/her body. He/she rotates under the rope and pulls with his/her hands and arms make progress until across the obstacle. No more than three (3) Raiders will be on or clipped (carabineer closed) onto the rope bridge simultaneously. No part of the body or equipment may touch the obstacle (dead zone) when hooking up or getting off the rope bridge. (Do not touch the boundary marker or any part of the obstacle). Raiders are not required to have one leg or foot in contact with rope bridge while clipped onto the rope.

d. Disassembly:

1) When the last Raider has crossed and unclipped from the rope bridge the far side anchor may be untied while the near side Raider disassembles the transport system on the near side. He/she can tie a bowline w/overhand in the end of the bridge rope or uses the existing Wireman's or Figure 8 slip knot and secures the snap-link on his/her rappel seat or harness. The knot may be tied during construction or crossing. The near side Raider is then belayed across the obstacle by Raiders on the far side.

2) Once the near side Raider is across, all tied knots/carabineers (the wireman's knot or figure 8 slip knot and bowline knot) will be untied or removed from the bridge rope. When the team leader is certain that all tied knots/snap links/carabineers are removed or untied from the rope, equipment and Raiders are accounted for and the obstacle has been cleared, he/she will call "TIME". No individual equipment needs to be removed nor do any Swiss seats/around-the-waist harnesses untied and removed.

6. SCORING: The score earned by the Team is the total time based the time for the crossing plus any penalty time.

7. PENALTIES: Twenty (20) second penalties are assessed for the following rule violations, except as otherwise noted.

ANNEX B: (ONE-ROPE BRIDGE) to the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet (MOI), One-Rope Bridge

a. Equipment/Preparation/Inspection Penalties:

- 1) Raider team not having at a minimum, 120-foot-long by 7/16-inch diameter static bridge rope, ten (10) Swiss seat ropes 14ft. by 7/16-inch diameter and required number of snap links to build the bridge.
- 2) Any Swiss Seat or Swami Belt that is determined unsafe.

b. Construction Penalties:

- 1) Far side Raider fails to secure the bridge rope to his/her waist harness with a figure 8 or bowline knot w/overhand and snap-link.
- 2) The far side Raider improperly belayed across the stream.
- 3) The far side Raider fails to tie one of the approved anchor knots.
- 4) Failure to tie the wireman's knot or figure 8 slip knot – if the team must retie for safety – time continues to run. The wireman's knot must naturally lie toward the near-side anchor and both ends should exit opposite each other without any bends, the loop formed in the wireman's and figure 8 slip knot must not be less than twelve (12) inches in length, and the steel carabineer opening gate must be up, locked, and away from the loop, if two snap links are used gates must be opposite, and form an X when locked.
- 5) Failure to secure the bridge system on the far side or near side with round turns with two (2) half hitches on a bight.

c. Crossing Penalties:

- 1) Mounting (clipping onto) the bridge rope before all bridge knots are secure.
- 2) More than three (3) Raiders on the bridge rope or clipped onto the bridge rope at any one time. More than four (4) Raiders -- disqualified.
- 3) Each Raider while mounting/dismounting that touches the obstacle with his/her body this includes members on the far and near side attempting to assist Raiders who are crossing and any equipment that the raider loses in the obstacle while crossing or mounting and dismounting of the bridge.

**NOTE:** Once mounted, crossing Raiders “CAN” touch while crossing, as long as they don't push off with their FEET and they don't stand up and run across.

- 4) Uniform/equipment dropped into the obstacle is a ten (10) second team penalty per occurrence.

- 5) Less than seven (7) Raiders crossing on the rope bridge -- disqualified.

d. Disassembly Penalties:

- 1) Near side Raider fails to secure the bridge rope to his/her waist harness with a figure 8 or bowline knot with overhand, or transport knot and snap-link before entering into the dead zone.
- 2) All tied knots/snap links not removed from the rope.

e. Other:

- 1) Safety issues – clock runs while corrected.
- 2) Sportsmanship – profanity, abusive or unethical conduct – possible disqualification depending on the nature of the conduct.




ANNEX C: (CROSS-COUNTRY RESCUE) to the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet (MOI), Cross-Country Rescue

1. **TASK:** A 10-member Raider Team will transport a simulated casualty over approximately one-mile course on unimproved terrain and transfer casualty to a simulated helicopter (a marked area 12 feet by 7 feet will simulate the cargo area of a helicopter). There will be obstacles such as (low crawl, hurdles, tires, and walls) that all team members, along with the weighted litter and ruck sacks, must negotiate along the route. The objective is to complete the course in the shortest time.
2. **CONDITIONS:** The uniform for the Cross-Country Rescue is ACU trousers, rigger belt, team, or tan t-shirt, ACU jacket and running shoes and some type of water carrying devise (pistol belt, full canteen with cover, water bottle, Camel Back). Each Raider team must begin and end this event with the same 10 members. No substitutes are allowed after the event starts. Each Raider team will carry a litter with a pre-tied container(s) weighing approximately 80 pounds and three rucksacks with each weighing approximately 25 pounds over a marked course. Each Raider team will be given 5 minutes to prepare the three (3) rucksacks and simulated/empty litter. The pre-tied containers will be sufficiently secured to a litter for the team at a designated point on the course. There will be approximately five obstacles that all team members, the simulated casualty (weighted litter) and ruck sacks must negotiate along the route. Near the end of the route there will be an area 12 feet by 7 feet to simulate the cargo area of a helicopter.
3. **STANDARDS:** All 10 Raider team members will move to the preparation area. Upon arrival of the first cadet, the 5-minute preparation time will begin. The Raider team captain will notify the evaluator when the team is ready to begin. Upon the command “GO” each Raider team will transport the simulated/empty litter and the rucksacks along the marked course. Upon reaching the obstacle, all team members and equipment must negotiate all obstacles. Once the team reaches the designated point on the course with the simulated casualty (weighted litter), they will ground the simulated/empty litter and pick up the simulated casualty (weighted litter) and continue on the marked course. When they return to where they picked up the simulated casualty (weighted litter), they will place the simulated casualty on the ground (weighted litter), pick up the simulated/empty litter, and load it into the simulated helicopter. The entire litter must be inside the marked area before continuing. Once the casualty is on the simulated helicopter and evaluator tells the team to continue, they will pick up the simulated/empty litter and return to the start point where there will be a 2nd simulated helicopter area marked. All team members, simulated/empty litter and 3 rucksacks must be in the 2nd simulated helicopter (marked area) before the team commander calls “TIME” and their time stops.
  - a. Equipment will not be thrown or dragged (except under the obstacle).
  - b. The rucksacks will not be carried on or attached to the litter in any manner.
  - c. Each Raider team commander may task organize their teams and decide how many cadets will carry the litter, who is carrying the rucksacks and how they switch off during the actual event.
  - d. A Raider team member can put their equipment in the simulated helicopter cargo cabin and go back to assist their team members. All team members must remain within line of sight of each other.
  - e. Once all Raiders and all equipment are on the simulated helicopter time will stop. A **5 minute penalty** will be added for any equipment not on the 2nd simulated helicopter when time is called by the team commander.

ANNEX D: (TEAM RUN) to the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet (MOI), Team Run

1. **TASK:** Each team must complete a 5 km team run over a designated marked course.
2. **CONDITIONS:** During daylight hours and under existing weather conditions, each 10-member Raider team will negotiate approximately a 5 km course in their prescribed Raider uniform (ACU trousers, team or tan t-shirt, running shoes and some type of water carrying devise (pistol belt, full canteen with cover, water bottle, Camel-Back). Team members must stay together and remain within 20 meters of each other during the final 300 meters of the course. Coaches, parents, chaperones or other non-competing Raiders are not allowed to run with the team.
3. **STANDARDS:** Team scores are based on the total time it takes for the team to finish the course. All Raider team members must cross the finish line within 20 meters (**THAT IS CLEARLY MARKED**) of each other and the time will stop when the last member of the team crosses the finish line. If any Raider violates the 20-meter rule there is a **30 second penalty** for each Raider in violation. Raider team members cannot push, pull, hold hands or carry their teammates at any time during the Team Run event. A **50 second penalty** will be added to the run time for violating this safety rule. At no time may a coach, non-competing cadet, parent, chaperone or cadre run along or “pace” a Raider team. Any Raider team caught violating this rule is **DISQUALIFIED**. If for any reason a Raider team member drops out of the Team Run event after the run starts, the team will ensure the cadet is cared for by seeking immediate medical attention or other assistance needed. Once help arrives, the rest of the team can finish the run if so desired. Teams will incur a **five (5) minute penalty** for each team member not completing the run. If a team misses their designated start time they will incur a **one (3) minute penalty**.
4. **CONCEPT:** Each Raider Team will report to the Team Run area and line up by teams in the order provided on their rotation matrix. The judge will start each team in 30 second intervals. Thirty (30) seconds after the team listed immediately before them on the rotation matrix, the judge will give the command “Get Ready” and “Go.” Time will stop when all Raiders have crossed the finish line. No stopwatches will be used to keep time. The judge will record the actual start and stop time on a single scoring matrix – individual Team Run score sheets will not be used.

ANNEX E: (TIRE FLIP) to the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet (MOI), Tire Flip

1. **TASK:** 10-member Raider teams will flip a large tire a distance of 50 meters, cross a mid-point line and flip the same tire back to the start/finish line. Team captains will structure their teams into two groups of five cadets each. Time begins at the command of “Begin” and stops when the whole tire is completely across the start/finish line and on the ground.

2. **CONDITIONS:** Event is a relay style for time. Uniform for this event is OCP/ACU jacket, ACU trousers, boots or running shoes, **GLOVES ARE OPTIONAL**. This event will take place in a grassy area/field marked in lanes approximately 50-meters long by a minimum of three meters wide. See diagram below. Team captains will structure their teams into two groups of five cadets. Each team type will flip the same size tire. The judge will command “Get Ready” then “Begin.” Time stops when the tire comes to a rest across the start/finish line. The female and JV tire will not weight over 400 pounds, the mixed tire will not weight over 550 pounds and the male tire will not weight over 700 pounds.

3. **STANDARDS:** The first group of five moves forward from a near side ready line, flips the tire 50 meters out, past a midpoint line. The second group of five will move forward from a far side ready line and flips the tire back past the finish line. The members of the other section not flipping cannot lead or follow the section doing the flipping. Time starts when the judge commands “Begin” and ends when the tire comes fully to rest past the start / finish line.


In the interest of safety, all five team members must always remain behind or to the side of the tire. The first group of five will flip the entire tire past the mid-point line and let it come to rest before the second group of five comes forward to begin flipping the entire tire past the start line. The judge will accompany the five member teams to observe and monitor all safety concerns. The tire is not allowed to twist or roll while being flipped. The tire must always remain completely within the lane while being flipped. If any portion of the tire comes in contact with the boundary line the team has committed a lane violation.

4. **SAFETY:** Team members cannot stand or move in front of the tire as it is being flipped.

5. **PENALTIES:**

- a. Allowing the tire to roll in order to cover more ground: **30 seconds**
- b. Allowing the tire to twist in order to cover more ground: **30 seconds**
- c. Cadets moving forward from the ready line before tire comes to rest: **30 seconds**
- d. Lane violation: **30 seconds**
- e. Intentional safety violation: **disqualified**
- f. Sliding the tire to cover more ground: **30 seconds**
- g. Intentionally rolling tire: **disqualified**

ANNEX H: (Cadet Uniform Standards) to the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet (MOI)

11-3. Cadet Uniforms

a. Authority. Each Cadet authorized to participate in JROTC may be furnished, at government expense, in-kind uniforms. The authority for issuing in-kind uniforms to Cadets is CTA 50-900. Schools that provide a Cadet-type uniform or desire to purchase issue-type uniforms from the Army or commercial sources may be authorized to do so in place of receiving Army-issued uniforms at no cost to the Government. The operating policies and procedures concerning the supply of issue uniforms to schools are outlined in AR 700-84.

b. Types of uniforms. This section outlines basic policies on uniforms for JROTC Cadets and students. The Army uniform and the OCP/ACU are authorized for wear by JROTC Cadets. The Class A or B uniform is the standard for the classroom and campus. The OCP/ACU is to be worn only on an exceptional basis for adventure training, JCLC, or special team activities, but not on campus during the school day. Cadre may request to wear the OCP/ACU in exceptional circumstances. The request must be signed by either the principal or superintendent and be sent through brigade to USACC.

1) Army issue uniform. This uniform is identical to that issued to enlisted members of the Army Active, Reserves, and National Guard. JROTC units electing to wear the Army issue uniform must comply with the following guidelines.

(a) Uniform wear and display of ribbons and accouterments must comply with this regulation.

(b) Army issued uniforms must include insignia which distinguish them from standard active duty Active Army uniforms.

2) Distinctive uniform. This uniform must be so distinctive in design and/or fabric that it cannot be confused with an Army uniform. Units electing to wear distinctive uniforms must request and receive approval, from USACC, for uniform design, style, and material.

c. The mix of civilian attire with the Army uniform, such as school jacket, sweater, etc., is not authorized.

d. Institutions are encouraged to support drill teams, raider teams, rifle teams, drum and bugle corps, bands, color guards, and other appropriate integrated-curricular activity teams. Modification of the Army uniform for these activities is not authorized. However, special uniform accessories such as chrome helmets, and colored webbing are acceptable if obtained at no cost to the government.

ANNEX H: (Cadet Uniform Standards) to the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet (MOI).

#### 11-5. Uniform Appearance

- a. Uniforms must present a neat and clean appearance. Loose strings will be cut from the uniform. No jewelry, watch chain, combs, checkbooks, pens, pencils or similar items will appear exposed on uniforms. The Army uniform will not be mixed with civilian clothing. Bulky items in pockets distract from the uniform. While in uniform, Cadets will not place their hands in their pockets except momentarily to place or retrieve items.
- b. Headgear is part of the uniform. Cadets are required to wear the gray berets while outdoors or when carrying air/drill rifles or a saber. The gray berets with a distinctive flash is the only authorized headgear to be worn with the dress uniform.
- c. Cadets are approved to wear the following religious headgear with the JROTC uniform: turban, hijab and yarmulke. Headgear will be conservative and subdued in color (black, brown, green, dark or navy blue or a combination of these colors). The headgear cannot bear any writing, symbols or pictures. Cadets may wear approved religious headgear in place of military headgear (e.g., turban and hijab). Standard JROTC headgear will be worn when it can completely cover the religious headgear (e.g., yarmulke). Approved headgear are authorized for wear during all JROTC activities (i.e., drill team, color guard, parades, speaking engagements, etc.) that do not pose a risk to the safety of the Cadet, Cadre or others. For example, a Cadet wearing religious headgear can be exempted from certain —Special Hazard Training events that may result in injury to the Cadet or support personnel such as obstacle courses / rappelling etc.
- d. To ensure consistency across the JROTC program, exceptions to Cadet uniform policies will be forwarded to and approved by the Commander, USACC on a case-by-case basis. To ensure appropriate compliance with current laws and regulations, the Commander, USACC will forward recommendations for disapproval to the Army G-1 within 30 days of the initial request for final adjudication.

#### 11-6. Personal Appearance

JROTC is a uniformed organization which is judged, in part, by how a Cadet wears a prescribed uniform and maintains their personal appearance. Therefore, a neat and well-groomed appearance by all Cadets is fundamental to JROTC and contributes to building the pride and esprit essential to an effective Corps of Cadets.

- a. Hair Styles. Many hairstyles are acceptable, as long as they are neat and conservative. Hair will be neatly groomed. Hair that is clipped closely or shaved to the scalp is authorized. The length and bulk of hair will not be excessive or present a ragged, unkempt, or extreme appearance. If dyes, tints, or bleaches are used, colors used must be natural to human hair and not present an extreme appearance. Hair style will not interfere with proper wearing of military gear. The headgear when worn in uniform will not appear bulging or distorted, and without excessive gaps between the headgear and the head. There is no minimum hair. Hair that falls over the eyebrows or ears will be pulled back. Hair holding ornaments (barrettes, pins, clips, headbands), if used, must be transparent or similar in color to hair, and will be inconspicuously placed. Headbands should not be wider than 1 1/2 inches. Cadets are permitted to wear a ponytail, two braids, or one singular braid in all uniforms. Cadets are authorized to wear multiple neat-in-appearance hairstyles at once. Colors that detract from a professional uniform appearance are prohibited. It is the responsibility of instructors to use good judgment in determining if applied colors are acceptable, based upon the overall effect on Cadets' appearance.

ANNEX H: (Cadet Uniform Standards) To the Broward County LTC John Stauffer, JROTC Raider Challenge Championship Meet (MOI)

1) Facial hair: Sideburns will be neatly trimmed. Sideburns will not extend below the lowest part of the exterior ear opening. The face will be clean-shaven, except for permitted mustaches.

b. Fingernails: All cadets will keep fingernails clean and neatly trimmed. Female cadets are permitted to wear any color fingernail polish if they match in type and style. Do not extend more than ½ inch for acrylic nails from the tip of the finger.

c. Hygiene and Tattoos. Cadets are expected to maintain good hygiene while in uniform. Tattoos are authorized; however, tattoos or brands that are extremist, indecent, sexist, or racist are prohibited. except in areas of the body which would cause the tattoo to be exposed while in Class A uniform. Tattoos or brands that are extremist, indecent, sexist, or racist are prohibited. If a cadet has a tattoo on the face, it will not prohibit the cadet from participating in JROTC. Instructors should advise that facial tattoos could prohibit the cadet from joining the Armed Forces.

d. Lipstick: Female cadets may wear non-extreme shades of lipstick.

e. Religious wear.

1) Cadets may wear religious headgear while in uniform as long as it meets the following criteria.

(a) It must be subdued in color (black, brown, green, dark or navy blue, or a combination of these colors).

(b) It must be of a style and size that can be completely covered by standard military headgear.

(c) The headgear cannot bear any writing, symbols, or pictures.

2) Exceptions to appearance standards based on religious practices.

(a) The term religious apparel is defined as articles of clothing worn as part of the observance of the religious faith practiced by the Cadet. Religious articles include, but are not limited to, medallions, small booklets, pictures, or copies of religious symbols or writing carried by the individual in wallets or pockets. Except as noted below, Cadets may not wear religious items if they do not meet the standards of this regulation. Requests for accommodation will not be entertained.

(b) Cadets may wear religious apparel, articles, or jewelry with the uniform, if they are neat, conservative, and discreet. —Neat conservative, and discreet is defined as meeting the uniform criteria of this regulation. In other words, when religious jewelry is worn, the uniform must meet the same standards of wear as if the religious jewelry were not worn. For example, a religious item worn on a chain may not be visible when worn with uniforms. The width of chains worn with religious items should be approximately the same size as the width of the ID tag chain.
